At 7:00 p.m. Monday, August 8, 2022, Mayor Ralph Kingan called the regular Town Council Meeting to order with the following being present Mayor Ralph Kingan, Councilman Justin Robb, Councilman Doug Schrader, Councilman Joel Morgan, Councilman Mike Phipps. and Clerk/Treasurer Barbara Craig. **CONSENT AGENDA:** Councilman Morgan made a motion to approve the Consent Agenda. Items approved under the Consent Agenda include: The regular meeting minutes conducted on July 25, 2022. Approval of Vouchers in the amount of \$97,639.59 including payroll. Motion passes with all ayes. **CITIZEN COMMENTS:** None. **WRITTEN COMMENTS:** None. **CONTRACTS:** None. **APPOINTMENTS:** None. **UNFINISHED BUSINESS:** None. **NEW BUSINESS:** Councilman Phipps made a motion to Approve Resolution 2022-09 with changes from previous Resolution to include the cost estimate and the town of Wright's matching funds, A Resolution authorizing submission of an Application to the State Loan and Investment Board for a Grant through Water and Sewer ARPA Grant Program funding on behalf of the governing body for the Town of Wright, for the purpose of installation of additional sewer main extending from Chad Road to Melicia Drive to service future development, the Grant application will be in the amount of \$882,000.00 the Town of Wright will have a 16% match in the amount of \$168,000.00. Total amount estimated cost will be \$1,050,000.00, with no further discussion Councilman Morgan seconded the motion. Motion carried with all ayes. Councilman Morgan made a motion to approve the request for the traffic control for the clothing exchange and food truck delivery at the Wright Community Center on August 19, 2022 which would be traffic flow along the northbound section of Wright Blvd in the area of the Wright Community Center which would control cross traffic coming out of the Community Center with volunteers directing traffic flow, Councilman Phipps seconded the motion. Motion carried with all ayes. **ANNOUNCEMENTS:** Candidate Night will be held Tuesday, August 9, 2022, at 6:00 p.m. at the Wright Town Hall. The Primary Election will be held August 16, 2022, from 7:00 a.m. to 7:00 p.m. at the Wright Town Hall. The next Town Council meeting will be held on Monday August 22, 2022, at 7:00 pm.
