On Monday June 26, 2023, at 7:00 p.m. Mayor Ralph Kingan led the Pledge of Allegiance and called the regular Town Council meeting to order with the following being present, Mayor Ralph Kingan, Councilman Doug Schrader, Councilman Justin Robb, Councilman Joel Morgan, and Clerk/Treasurer Barbara Craig. Absent: Councilman Mike Phipps. **CONSENT AGENDA:** Councilman Morgan made a motion to approve the Consent Agenda. Items approved under the Consent Agenda include the regular meeting minutes conducted on June 12, 2023. The Consent Agenda for June 26, 2023.
