With no public comments the public hearing adjourned at 7:02 p.m. At 7:02 p.m. Mayor Ralph Kingan led the Pledge of Allegiance and called the regular Town Council meeting to order with the following being present, Mayor Ralph Kingan, Councilman Doug Schrader, Councilman Justin Robb, Councilman Mike Phipps, Councilman Joel Morgan, and Clerk/Treasurer Barbara Craig. **CONSENT AGENDA:** Councilman Morgan made a motion to approve the Consent Agenda. Councilman Robb made a motion to approve Catering Permit # 2023-003 for Hanks Bar & Grill for the Taste of Wright on June 15, 2023, to be held at the Southern Campbell County Ag Complex, Councilman Robb seconded the motion.
