This Ordinance is to establish and confirm that the entirety of Lot 12A, not just the Northern portion is zoned as Light Industrial District changing the Southern portion from Public Facility District to Light Industrial District, Councilman Schrader seconded the motion. Motion carried with all ayes. Councilman Phipps made a motion to approve Resolution 2023-05. A Resolution authorizing submission of an application to the Land and Water Conservation Fund Grant Program. The Town of Wright has identified the need for resurfacing the walking path at the Visitor Center and has established a project called the Visitor Center Sidewalk Resurfacing Project, Councilman Lembke seconded the motion. Motion carried with all ayes.
